ELIGIBILITY FOR MEMBERSHIP

Membership in the Association is open to persons who: (1.) Served in or were employed by military commands located on the Center, or (2) Are spouses, widows, widowers, or children of veterans, as defined below, who served in military commands located on the Center.

Member of the Association shall be classified as follows for IRS reporting purposes:

War Veterans: Persons who served in the United States Armed Forces during a period of war (war periods are as defined by federal law).

Veterans other than War Veterans: Present or former members of the Armed Forces of the United States other than those classified as War Veterans.

Spouses: Include only spouses, widows, or widowers of veterans who are or would be eligible for membership.

Cadets: Include only students in college or university ROTC programs or at Armed Forces academies.

Civilian employee: Civilian employees of military activities located on the Center.

Children of eligible veterans: Children, of veterans who are or would be eligible for membership.

The Association may give priority to or limit membership in some membership categories to maintain its status as a tax-exempt veterans organization under current laws.
